From the Executive Director

Dear Friends of Cancer Lifeline,

Every day I am reminded how fortunate we are for all of the support of our volunteers here at Cancer Lifeline. Not only are we powered by volunteers on the Lifeline, but our 20 board members and our 31 advisory board members and countless other volunteers give their time, donations and expertise to keep Cancer Lifeline rolling forward. It is with their guidance and energy that Cancer Lifeline has grown slowly but steadily over the years, always striving toward the goal of serving more people with cancer in more communities.



To do this we recognized the need to be in the communities where people are and so our model has shifted from being location centric with our Green Lake home base to branching throughout the Greater Seattle area.

I'm pleased to announce that in 2018, we renewed all of our current hospital partnerships with Northwest Hospital, EvergreenHealth, and Valley Medical Center.

Plus we also launched three new partnerships:

- After confirming our partnership with Overlake Medical Center in 2017, we saw steady increase in attendance in our first full year of new programs at their Bellevue campus.
- Our programs came online with Seattle Cancer Care Alliance Proton Therapy Center in the Northend at the Northwest Hospital campus.
- In the Fall of 2018, we finalized our contract with Virginia Mason Cancer Institute, paving the way for our services to be accessible on First Hill in Seattle and in Federal Way.

As we bring Cancer Lifeline into more communities, our footprint expands slowly but steadily. The key to our success is the steadfast focus and energy of our volunteers and our relationships with key administrators, social workers and doctors who know first-hand the value of our work in optimizing the lives of people with cancer. Our values are strong in the programs we produce and we work closely with our facilitators to understand the needs of our clients.

In this report you will see a snapshot of our community impact: how many classes we offered, how many referrals we made, who

we've served, and how we did it. The most important ingredient in all of these successes is the quality of our relationships and it all starts with our volunteers. On behalf of the team, I want to thank all of our volunteers for their great work.

stakeholder and passionate advocate for people living with cancer. Her leadership was pivotal as she joined David and Patricia Giuliani to contribute funds for much-needed building improvements. Together, these gifts have assured that Cancer Lifeline can remain in the Dorothy O'Brien Center.

Recently we asked Monica a few questions about her commitment to Cancer Lifeline and her role as an active philanthropist.

Q: When did you first get involved with Cancer Lifeline?

MA: In 2016 I was a guest at the Resources for Hope dinner at Lynn Behar's table and I was so deeply moved by the intimacy and personal touches and stories presented that evening. It wasn't long before I was swept up by the Advisory Board and in 2017 and 2018 I co-chaired the event.

Q: What's the best part of your role with the Resources for Hope event?

MA: It's wonderful getting to know the variety of people in the community. As we create the event and generate interest and support, we have the opportunity to spread the word about Cancer Lifeline's work. There is a longevity of support for Cancer Lifeline that is remarkable. To witness the depth of generosity and compassion of these people is humbling.

Q: Why is it important to give to an organization to Cancer Lifeline?

MA: Cancer Lifeline is based in Washington State and its programs make a big difference in the lives of Washington residents. The Patient Financial Assistance Fund provides critical and timely financial assistance to our low-income clients and the new Patient & Family Support Fund serves ALL people living with cancer: patients, survivors, family members, friends and co-workers. Cancer Lifeline's programs radiate beyond the loving Green Lake headquarters on Fremont Avenue throughout our growing hospital partnerships. I wanted Cancer Lifeline to not have to worry about office space and be able to concentrate on reaching even more people living with cancer. ♡

Janell joined the ranks of Lifeline volunteers after completing the training last September. In no time at all, she signed up for a regular shift on the phones and is now a weekly volunteer at the Dorothy O'Brien Center.



"I found out about Cancer Lifeline through a catalog in the oncology department at EvergreenHealth. There was a presentation at Northwest Hospital that I was interested in, so I attended. I was very impressed by Basha, who facilitated that presentation," says Janell.

"I was looking for a volunteer opportunity. One day, I took a field

trip over to Cancer Lifeline, and rang the doorbell. Basha answered, and gave me a tour. I wanted to be like her: making a difference. As someone whose life has been changed by cancer in ways that I never wanted, I wanted to be able to help others whose lives have also been altered.

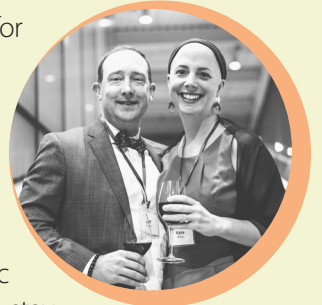

produce highly effective educational and instructive classes, support groups, and financial assistance programs that empower cancer patients and enhance the quality of their daily existence during one of life's most daunting challenges.

WHO WE SERVE

Low Income Clients

52% of clients have incomes at or below \$35,000 per year. 25% have income below \$15,000 annually. We work hard to continue to provide services free of charge so that everyone is able to receive the support they need.

Patients & Survivors

83% of all clients are cancer patients actively engaged in treatment or are survivors. Caregivers and loved ones make up the remaining 17%.

Cancer Types

Over 45% of all clients who use Cancer Lifeline's services have breast cancer. The remaining 55% include the entire realm of cancer types including colorectal, leukemia, lymphoma, lung, prostate, head & Neck, bladder, cervical, and skin cancer.

Ethnicity

25% of those we serve self-identify as minorities, including African American, Latinx, Asian, Native American, and Pacific Islander.

Age

40% of our clients are age 65 or older. 31% are between 55 and 64 years. Young adults below the age of 45 are one of the fastest growing age groups and now make up 27% of all Cancer Lifeline clients.

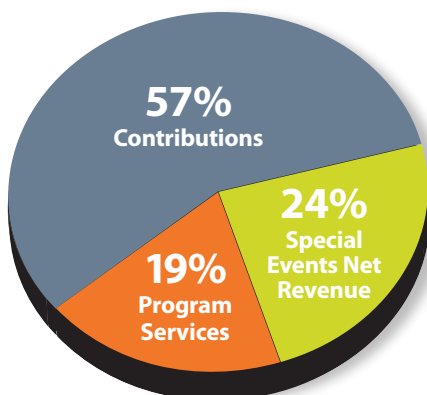

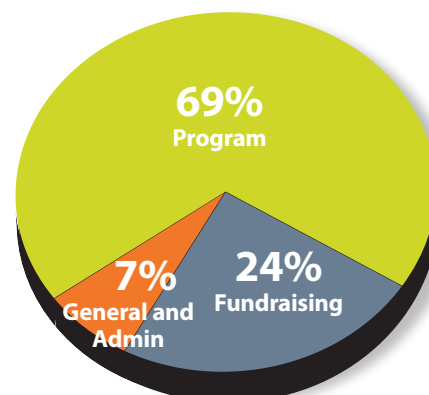
